

## Description

This is an advanced indoor environment sensor for LoRaWAN® wireless network. ERS Desk is a sensor for measuring desk occupancy and is designed to be mounted under a desk or table. It also has internal sensors for measuring indoor temperature, humidity, light intensity, and motion. ERS Desk is a battery-powered device. The motion sensor can be used for presence monitoring systems. ERS Desk is equipped with NFC (Near Field Communication) and can easily be configured from a smartphone.

#### Installation

The ERS Desk should be mounted under a desk or table where the occupancy needs to be measured. When installing, place the device far enough from the edge of the table to make sure it is not possible to reach by the user. Mounting close to the edge may result in damage to the device. See pictures for an example. The blue and red areas are the ranges of the two different occupancy sensors, make sure that the thermopile sensor is facing the front as shown.





1. Remove the back panel of the sensor with a small screwdriver.





2. Install the batteries. The ERS Desk requires one or two AA batteries. The battery type is 3.6V Lithium Battery (ER14505). You can use one battery, but it's recommended that you use two for best performance and battery life. Use battery slot A if only one battery is used.



Caution: Using batteries other than the ones provided may result in loss of performance and battery life, and also damage to the device. Dispose of properly, observing environmental protection rules.

3. Mount the back panel under the desk using some of the six mounting holes. It may also be mounted using adhesive tape.



4. Attach the sensor part to the back panel.





## Sensor configuration

All sensor settings can be configured via a smartphone application with NFC (Near Field Communication) or over the air via the network server and downlink data to the sensor. The sampling rate, spreading factor, encryption keys, port, and modes can be changed. All sensor settings can be locked from the server or NFC to make end-users unable to read or change settings on the sensor.

#### NFC Configuration

- Download ELSYS "Sensor Settings" application from Google Play or App Store (from iOS 13) and install it on a smartphone or tablet. The device must support NFC.
- 2. Enable NFC on the device and start the application.
- 3. Place your device on top of the NFC antenna on the sensor.



- 4. Remove the device. Current settings will be displayed in the application.
- 5. Use the application to change any settings if needed.
- 6. Quickly tap the device on top of the NFC antenna to give the new settings to the sensor. Make sure that the application confirms your new settings.
- 7. Wait for the sensor to reboot (5 sec), indicated by the LED flashing. Sensor settings have been updated.



#### Sensor behavior

#### NFC Read / Write

- When reading or writing NFC configuration data to the sensor, it starts a timer and delays its action 5 seconds.
- 2. After the delay, the sensor determines if the NFC data has changed or not. If it has changed, the sensor reboots and starts from power-up.
- 3. Write your settings in the application and then locate the NFC antenna of the phone and sensor. Keep the two devices close and don't move them to get the best connectivity as possible when writing or reading data to the sensor. Bad connection can be caused by long distance, wrong location, or rapid movement.




4. When you have written data to the sensor, let the sensor reboot and restart before trying to write again.

You should always validate your settings by reading the NFC data after the sensor has restarted.

#### Sensor startup


- 1. When the sensor starts up, it loads configuration from the internal memory and merges it with user configuration.
- 2. When the configuration is done, the sensor writes the new settings to the NFC chip. The sensor always writes new configurations to the NFC chip when something changes in the sensor or if NFC data is corrupted by an NFC writer or phone. The sensor always writes the new configuration to NFC chip at startup.
- 3. When the configuration is done, the sensor tries to join the network if OTAA (Over the Air Activation) is enabled.
- 4. The sensor LED flashes orange when it tries to join a network. It will try to join every 10 seconds initially. This interval will increase to save battery, at most up to one time per hour.
- After successful connection to a network, the sensor sends a settings packet and enters sampling mode.





configurations.




#### Motion detection range


Actual range of the sensor can be influenced by environmental conditions. Avoid installing the sensor in areas where it will face direct or reflected sunlight. Avoid installing near windows, air conditioning, or heating vents. Such placements will give false values.

The PIR can cause self-trigger if sensors are placed too close to each other. Keep this in mind when you mount or test the sensors.


Note: The PIR Lens has a blanking time of 20 seconds right after motion event and transmission. Any movements during this time will be ignored.

#### Desk occupancy

The combination between the infrared temperature sensor and motion detection sensor determines if the desk is occupied or not. The sensor will send three different values: Unoccupied = 0, Pending = 1 & Occupied = 2.

When the motion detector (PIR) is triggered, a scheduled infrared temperature (IR) measurement will happen after 20 seconds. The IR compares the temperature measured with the ambient room temperature to determine if the desk is occupied. If IR measures a temperature difference lower than a preconfigured threshold, occupancy is set to 0. The occupancy is set to 1 if the temperature difference is higher than the threshold.

When occupancy is set to 1, a new temperature measurement will happen every 60 seconds. If temperature difference still is above the threshold, occupancy is set to 2. The occupancy value will be 2 as long as the temperature difference is above the threshold.

If the temperature difference is below the threshold, occupancy is decreased to 1. Occupancy decreases to 0 when the temperature difference still is below the threshold in the next measurement.


#### Preconfigured temperature thresholds:

- 0.5 °C above when the ambient temperature is  $\geq$  25 °C
- 1.0 °C above when the ambient temperature is < 25 °C</li>

#### Examples of occupancy values:

- Occupancy 0: Unoccupied.
- Occupancy 1: Occupied but pending, meaning someone is either entering or leaving.
- Occupancy 2: Occupied.
